The Tournament reserves the right to pursue such misrepresentations without regard to time limits. By entering the PLCWC, all anglers, crews and guests, hereinafter referred to as Participant(s), agree to and understand that Tournament fishing and sportfishing in general have numerous obvious and non-obvious inherent risks that are always present in such an activity despite all safety precautions.
